# Electronics resource recovery

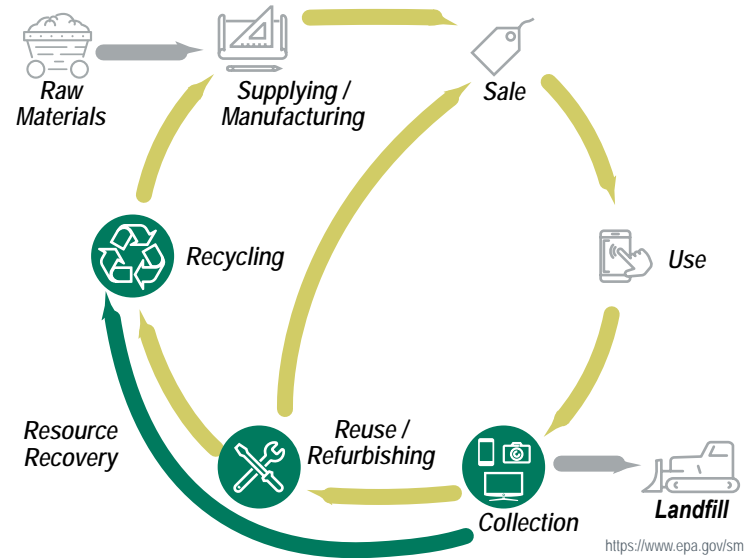

## E-Waste Framework and Roadmap

**Summary:** ERM was selected by a global technology company to assess their current e-waste management program and then develop a framework that addresses compliance gaps, and implements a program to mitigate future EHS compliance risks associated with new product development.

**Benefits:** The client now has clear visibility of their compliance obligations related to e-waste, which helps them better identify and plan around potential risks related to e-waste as they take new products to market. The global framework also provides transparency to the greater business for proactive e-waste management across their geographic footprint.

## Development of Recycler Verification Program

**Summary:** ERM co-developed a global audit program for a global consumer electronics company to assess and manage compliance of its e-waste vendors. ERM implemented a turnkey audit solution that assesses 80+ vendors annually on EHS compliance, downstream material flow, insurances and certifications.

**Benefits:** The program has successfully mitigated the business risk associated with using third-party vendors for e-waste recycling, with a reduction in governance program costs over 5 years by more than 50%. ERM continues to serve as their long-term partner, consistently providing year-on-year delivery, with insight and advice on continual improvement that evolves the program to match and alleviate changing market conditions.

## Scalable Audit Program Implementation

**Summary:** ERM led a pilot audit program for a multinational technology solutions company to assess compliance of three vendors against the e-Stewards standard, and create the foundation for our client's regional e-waste audit program. ERM partnered with the client to develop the program, execute the pilot and implement lessons learned. The pilot program has been scaled up to include turnkey audits of 17+ recyclers, and now includes follow-on actions with the recyclers to implement corrective actions and meet contractual obligations.

**Benefits:** The client now has full transparency on how their collected e-waste is being managed by their third-party recyclers. The learnings from the pilot program were used to update contract language with the recycling vendors to further protect the client's business interests. The scaled program continues to identify and curtail EHS and contract risks as they arise.

## Extended Producer Responsibility (EPR) Program Management

**Summary:** ERM evaluated and then streamlined a corporate EPR takeback reporting program for a global technology company by developing processes and tools designed to make reporting more efficient and meet deadlines consistently.

**Benefits:** With these tools in place, the client has now realized comprehensive compliance reporting services for 25 US states and the Canadian provinces in accordance with e-waste takeback laws. By streamlining their reporting solution, the client realized additional time savings of 100+ hours per year for two employees, which allowed them to focus on other critical business needs with support from ERM to meet routine compliance obligations.

## Third-Party Recycler Audit Program

**Summary:** ERM was selected by a global technology company to implement a global audit program of 100+ e-waste recyclers in 23 countries. ERM developed a standardized global audit protocol and reporting framework, deployed 40 trained auditors globally, and implemented a corrective action program for timely follow-up and resolution of identified issues.

**Benefits:** As a result of the program, audit reporting time has been reduced by 30%, freeing up the client to focus on other strategic initiatives, and corrective actions are being closed at a consistent rate. Through reliable and consistent on-time service and delivery, the client is able to better inform business stakeholders making key decisions about recycling partners as they work to establish a circular economy framework.
